The benefit of the COVID-19 Surveillance System is that it creates a structured screening system within your organization which will ultimately save you time and money, but more importantly allows you to safely reduce employee downtime.

COVID-19 evaluation and testing in our office, or at your place of business or job site, facilitates the logistics of evaluating your workforce in a timely and efficient manner and generates robust surveillance reports for you to make intelligent decisions about your entire workforce.

1. About This Report

This is an employee epidemiologic surveillance report produced by Buckhead Medicine based on surveillance data for the company listed above. The report is comprised of on-site evaluation with symptom reporting, vital sign measurements, COVID-19 RT PCR testing and COVID-19 serum IgM and IgG antibody testing. Risk of transmission is reported below as low, moderate or high. NP indicates test not performed.

3. Interpretation of Results

Date: Date that testing of individual employee was performed.

Symptoms: Any reported symptoms by employee related to COVID symptoms including fever, cough, shortness of breath or diarrhea.

Temperature: Abnormal temperature above 98.9

Pulse Ox: Abnormal Pulse Ox below 96%

Nasal PCR: COVID-19 Nasal PCR screening to evaluate for active infection. This test is performed by nasal pharyngeal swab. Sensitivity for this test is reported around 65 to 85%.

IgM: Blood test for COVID-19 serum antibodies. Early signs of immunity. When testing is available.

IgG: Blood test for COVID-19 serum antibodies. Later signs of immunity.

Transmission Risk: Risk of transmitting the virus to other people.

Contraction Risk: Risk of contracting the virus from other people.

Work from home: High probability of employee becoming infected by other employees due to lack of antibodies.

Isolate at home: High probability of employee infecting other employees due to active symptoms, abnormal vital signs or positive COVID-19 PCR test.

Work from home x 10 days: Patient moderate risk for transmission of COVID-19 to others as appears to be recently recovering from infection with positive IgM antibodies but negative IgG antibodies. Should work from home for next 10 days then will transition to work in office-contact precautions status.

Work in office - Airborne precautions: Employee with low risk of transmission to others due to absence of symptoms and negative PCR, and low risk of contracting the virus from others due to antibodies.
